THE PERSONNEL COMMITTEE WILL CONDUCT A REVIEW UPON HIRING TO EVALUATE THE ORGANIZATION'S EXECUTIVE COMPENSATION PROGRAM AGAINST THE COMPETITIVE MARKET. THE EVALUATION IS REVIEWED IF THERE IS GOING TO BE AN INCREASE OF 3% OR MORE OF SALARY IN ORDER TO ENSURE THAT THE COMPENSATION PROGRAM FALLS WITHIN A REASONABLE RANGE OF COMPETITIVE PRACTICES FOR COMPARABLE POSITIONS AMONG SIMILARLY-SITUATED ORGANIZATIONS. FOLLOWING THE REVIEW, THE COMMITTEE REVIEWS AND APPROVES BASE SALARY FOR SELECTED KEY EXECUTIVES. THE COMMITTEE REVIEWS AND RECOMMENDS THE SALARY FOR THE CEO, CFO, CDO MEDICAL DIRECTOR, EXECUTIVE PROGRAM DIRECTOR, AND FACILITIES DIRECTOR.
